All New Homes must be Water Efficient says Water Forum. The Water Forum calls for a national strategy for water conservation to make all new homes water efficient.

A secure supply of high-quality drinking water is essential for the health of every citizen and is critical for future economic growth and development. The population is set to rise by up to 40% by 2050 yet Uisce Éireann state that 58% of water supply zones have a supply risk at current demand. In recent years, we have experienced water supply restrictions during dry periods with national hosepipe bans in 2018 and 2020. Climate change will result in decreased rainfall in summer and longer dry and drought periods.

The Government has committed to building 33,000 homes every year for the next 10 years. This along with increasing population and greater economic activity will put additional demands on water resources. Climate change is predicted to reduce water availability. Making new homes water efficient could reduce domestic water demand by 20% and thus provide considerable water investment savings and reduce pressure on supplies.

"We sometimes forget that the water from our taps has been taken from a local river, lake or well and undergone a costly process of treatment and pumping before it reaches our homes," says Dr Matt Crowe of the National Water Forum. "We need to pay a lot more attention to conserving this precious and expensive resource so that there is an adequate supply available as our population increases and our climate changes. At a minimum, we need to ensure that all new homes are built to be water efficient'.

Updating Building Regulations to include mandatory water efficiency measures such as;

- Low flow showerheads
- Aerated taps
- Dual flush toilets
- Rainwater harvesting

will reduce water demand in new buildings and provide energy saving benefits, reduce costs to the taxpayer and help the environment. Civic Offices, Limerick Road Nenagh, Co. Tipperary

Saving water will reduce demand and ease pressure on supplies. The Water Forum believe that the Government needs a committed strategy for water conservation that includes a programme of actions to implement water saving measures nationally. A national water conservation team should be established to develop and implement a government-led water conservation strategy.
